Governor Orders Statewide Shutdown of Indoor Dining, Movie Theaters, Family Entertainment Centers as COVID-19 Cases Spike

The following must close statewide (eff. 7/13) – including in San Mateo County – under the governor’s emergency order:

- Dine-in restaurants (indoor)
- Wineries and tasting rooms (indoor)
- Movie theaters (indoors)
- Family entertainment centers (indoors)
- Zoos and museums (indoors)
- Cardrooms (indoors)
- Brewpubs, breweries, bars and pubs (indoor and outdoor)

Outside dining is still allowed
