2nd Micro Loan Program for South San Francisco Small Businesses

Small businesses in South San Francisco have an opportunity to apply for forgivable micro loans, for either \$10,000 or \$15,000. Businesses that meet preliminary eligibility criteria will be selected through a lottery to be considered for a loan.

The City has appropriated \$650,000 of its federal Community Development Block Grant for the Relief Fund, meaning roughly 50-55 South San Francisco businesses will secure a loan.

The second round of funding will go live on Wednesday, May 27, 2020 at 10:00 am and
